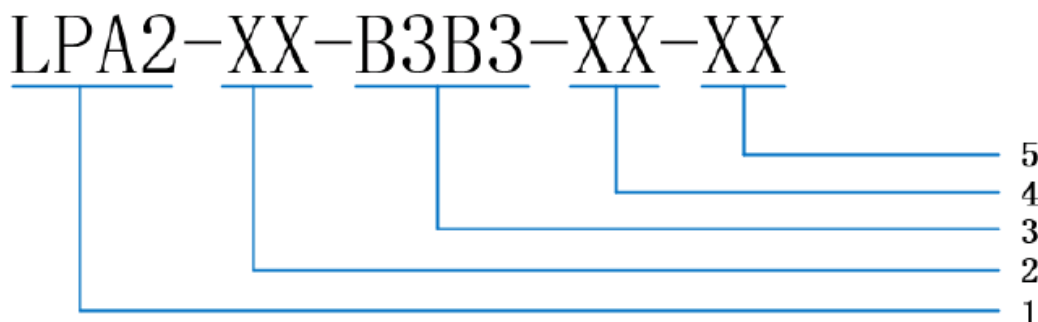

5. XX: represents customer code, example, 01HW, 10, 11NA. etc.
